






TERMS AND CONDITIONS

When holding a wedding at the terrace hotel the following contract terms will apply. If you have any questions or need additional information your hotel contact will be delighted to help.

How do I confirm a booking?

Your booking will be held provisionally for 2 weeks from the date you made contact with our wedding coordinator. To confirm your booking we require a £300 non refundable deposit and a signed copy of our terms and conditions.

When do we require payment from you?

50% of your full bill will be required 12 weeks prior and the remaining balance to be paid in full 10 days prior to your date. Payment can only be by cash, debit or credit card. Should the wedding bill remain unpaid the terrace hotel reserves the right to cancel the booking and claim cancellation charges.

Cancellations?

If in the unfortunate event you may have to cancel your wedding day, your deposit may be transferred to another available date within a 6 month period subject to availability. Written confirmation is required for all amendments and cancellations of your wedding day and a charge may be made equivalent to any loss suffered by the hotel.

Cancellation policy

In the event of cancellation the following charges will apply

- Cancellation of a confirmed booking loss of deposit.
- Cancellation with less than 6 months notice 50% of estimated total charge.
- Cancellation with less than 3 months notice 100% of estimated charge.
- All prices include VAT.

When do we need final numbers and menu details?

A revised number of guests are required one month in advance and final numbers and table plan must be confirmed and provided at least 72 hours before the wedding date. The final figure is the minimum number of meals for which you will be invoiced.

No food (with exception to celebration cakes) or drink is to be brought onto the premises without approval of the general manager. This includes miniature alcoholic beverages for use as favours, which must only be provided by the hotel. If your guests bring their own drinks onto the premises without permission, the drinks will be confiscated and a corkage charge will be payable by the wedding couple on departure.

The hotel reserves the right to charge you for any breakages or malicious damage to hotel property. The hotel will also charge you for additional cleaning required following a guest accident. Under no circumstances will any alcohol be sold toady under 18's and we may need to ask for proof of identification if necessary. Guests shall not affix any materials to

the walls or ceilings of the hotel by the use of nails, screws, pins or any adhesives. Confetti is not allowed in the hotel without prior permission from hotel management. LED candles only must be used in our function rooms, we do not permit candles or tealights with a naked flame.

Please note that all menu prices are subject to change due to unforeseen commodity price inflation on food or beverage. All confirmed bookings will be notified if such increases apply

We require the wedding couple to meet with our wedding coordinator four weeks in advance of wedding date to finalise all details and sign a wedding function sheet which outlines agreed details. Special dietary requirements and food allergies should be made known to the hotel at this time so any special menus can decided.

The hotel reserves the right to cancel any wedding booking that it deems will adversely affect the reputation, standing in the community or the safety of staff and other guests of the hotel prior to or during event.

The hotel will endeavour, where possible, to assist guests with storage of equipment, personal property, wedding cakes, etc. But cannot accept any loss or damage to same. A safety deposit box is provided in the hotel reception at the bride and grooms discretion. The hotel accepts no responsibility for any items lost or stolen on the premises.

Complimentary Room Hire:

If minimum numbers of 70 guests is not reached, room hire will be charged at £400. The Courtyard Suite will be charged at £250.

Civil Ceremonies:

It is the responsibility of the couple to liaise with and book local registrars to officiate your ceremony.
